The Department of Development Support and Environmental Management has approved this information packet for both Leon County and the City of Tallahassee. A location map of each street is included for reference.

Leon County New Street Name Notice

Project Mango Fulfillment Center:

A private commercial development. Located in Township 12, Section 18 1N, 1E.

- Levi Place – a new privately maintained street with an address range of 2400-2750.
- Smile Lane – a new privately maintained street with an address range of 6510-6520.
- Vineland Drive - a publicly maintained street has been approved to extend north of Mahan Drive connecting with Thornton Road. The extended address range is: 2050-2700.
- Sahano Acres – Effective September 9, 2021 this street name will be rescinded and no longer meet criteria for a named street. This action is required because two (2) homes on this named street will be removed within this project boundary. The one (1) remaining home will be addressed to Thornton Road.

Located in Villa Mitchell Subdivision and extending through Florida A & M University Campus – In Township 41, Section 01, 1S 1W.

Gamble Street east off FAMU Way has been renamed to - ***Robert and Trudie Perkins Way***.




