

A RESOLUTION OF THE CITY OF TALLAHASSEE, FLORIDA, APPROVING THE HONORARY DESIGNATION OF CAMPBELL STREET IN TALLAHASSEE, LEON COUNTY, FLORIDA, AS "E. LILYAN SPENCER MEMORIAL WAY" AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on December 11, 2024, the City of Tallahassee City Commission recommended an honorary designation of Campbell Street to E. Lilyan Spencer Memorial Way as shown on Exhibit A (the "Roadway"); and

WHEREAS, Eldis Lilyan Spencer was a lifelong Tallahassee resident born in 1905; and

WHEREAS, Eldis Lilyan Spencer graduated from Lincoln High School and earned a bachelor's in mathematics with a special certification in administration and supervision from Florida A&M University; and

WHEREAS, in 1941 Eldis Lilyan Spencer was recruited to be the second Principal of Bond Junior High School (now Bond Elementary School) and during her 10 years as Bond's Principal also served as the Athletic Director and coach for the boys' and girls' basketball teams; and

WHEREAS, Eldis Lilyan Spencer lived at 825 West Eugenia Street and was a very active member of the Bond community and served as the Chairperson of the women's day program and was a longtime member of Fountain Chapel A.M.E. Church on Eugenia Street; and

WHEREAS, Eldis Lilyan Spencer served on the Leon County Negro Auxiliary Christmas Seal Sale Committee for year-round tuberculosis control and chaired the Negro Division of the March of Dimes campaign, raising more money for children with polio than any other division. She also played an integral role in establishing and served as the Treasurer for the Bond Community Credit Union; and

WHEREAS, Eldis Lilyan Spencer passed in Tallahassee on January 24, 1957, leaving a legacy of a dedicated community activist and champion of children's education; and

WHEREAS, the request is to establish an honorary designation of the Roadway to E. Lilyan Spencer Memorial Way; and

WHEREAS, the City of Tallahassee has reviewed the request and finds that the Roadway should be established as an honorary designation to E. Lilyan Spencer Memorial Way.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TALLAHASSEE, FLORIDA:

Section 1. The City Commission hereby declares and honorarily designates the Roadway to E. Lilyan Spencer Memorial Way.

Section 2. City staff are authorized and directed to take any and all further action necessary to effectuate the intent of this Resolution.

Section 3. This Resolution shall take effect March 3, 2025.



A RESOLUTION OF THE CITY OF TALLAHASSEE, FLORIDA, RE-NAMING OKALOOSA STREET FROM KEITH STREET TO ALTHEA GIBSON WAY TO DR. CAROLYN RYALS WAY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 9-98 of the Tallahassee Land Development Code provides for the re-naming of City streets; and

WHEREAS, On November 6, 2024, the City of Tallahassee City Commission requested to re-name the roadway currently known as Okaloosa Street from Keith Street to Althea Gibson Way to Dr. Carolyn Ryals Way as shown on Exhibit A (the "Roadway"); and

WHEREAS, Dr. Carolyn Ryals moved to Tallahassee in 1953 to pursue higher education at Florida A&M University (FAMU); and

WHEREAS, Dr. Carolyn Ryals was a celebrated teacher, business owner, and volunteer; and

WHEREAS, Dr. Carolyn Ryals served the community through roles on the boards of the C. K. Steele Sr. Foundation and the Tallahassee Shelter, and with the Tallahassee Mayor's Task Force to End Homelessness and the Coalition for Homelessness; and

WHEREAS, Dr. Carolyn Ryals was a fierce champion for education in the community and spearheaded programs like Passion for Reading; and

WHEREAS, Dr. Carolyn Ryals was recognized as a 2016 Silver Star by the Tallahassee Senior Center Foundation; featured in the Tallahassee Community College's 2010 Cherry Hall Alexander African American History Calendar as one of the Capital City's most influential African Americans; and awarded the 2004 FAMU Distinguished Alumni Award for Community Service; and

WHEREAS, Dr. Carolyn Ryals passed on September 17, 2024, leaving a legacy of educational excellence in the community and dedication to helping others; and

WHEREAS, the request is to re-name the Roadway to Dr. Carolyn Ryals Way; and

WHEREAS, the City of Tallahassee has reviewed the request and finds that the Roadway should be re-named to Dr. Carolyn Ryals Way.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TALLAHASSEE, FLORIDA:

Section 1. The City Commission hereby declares and re-names the Roadway to Dr. Carolyn Ryals Way.



A RESOLUTION OF THE CITY OF TALLAHASSEE, FLORIDA, RE-NAMING OSCEOLA STREET FROM SOUTH ADAMS STREET TO ALTHEA GIBSON WAY TO RUDY HUBBARD WAY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 9-98 of the Tallahassee Land Development Code provides for the re-naming of City streets; and

WHEREAS, On December 11, 2024, the City of Tallahassee City Commission requested to re-name the roadway currently known as Osceola Street from South Adams Street to Althea Gibson Way to Rudy Hubbard Way as shown on Exhibit A (the "Roadway"); and

WHEREAS, Rudy Hubbard was born in Ohio in 1946 and moved to Tallahassee in 1974 to serve as the Head Football Coach at Florida A&M University (FAMU) until 1985; and

WHEREAS, Rudy Hubbard played as a running back at Ohio State from 1965-1967 and served six seasons as Ohio State's first Black Assistant Coach; and

WHEREAS, Rudy Hubbard built a winning record of 83-48-3 across 12 seasons with FAMU, leading the Rattlers to consecutive Black College Football National Championships in 1977 and 1978; and

WHEREAS, Rudy Hubbard led the team to win the inaugural NCAA Division I-AA (now Football Championship Subdivision) Football Championship in 1978, which FAMU remains the only historically black college to win; and

WHEREAS, after a coaching hiatus, Rudy Hubbard reappeared on the sidelines of James S. Rickards High School as the head coach from 2008 to 2011; and

WHEREAS, Rudy Hubbard is well-recognized for his coaching career as a 1990 FAMU Hall of Fame inductee, a 2021 College Football Hall of Fame inductee, and a 2021 recipient of Tallahassee's Key to the City; and

WHEREAS, the request is to re-name the Roadway to Rudy Hubbard Way; and

WHEREAS, the City of Tallahassee has reviewed the request and finds that the Roadway should be re-named to Rudy Hubbard Way.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF TALLAHASSEE, FLORIDA:

Section 1. The City Commission hereby declares and re-names the Roadway to Rudy Hubbard Way.

Section 2. City staff are directed to transmit a copy of this resolution to the United States Post Office, Leon County Development Support and Environmental Management, Tallahassee Police Department, Leon County Sheriff's Office, Emergency Management Agency, Tallahassee Fire Department, and Leon County Emergency Medical Services.
