SITE PLAN (All Signs):

The site plan may be drawn on either a letter size, legal size, or a plan size page. The site plan must be drawn to scale and must show: (1) locations of all off-site signs and structures presently on site; (2) parcel boundary lines; (3) adjacent roadways (with street names); (4) proposed location of sign; (5) sign orientation; (6) a north direction arrow; (7) designated landscape areas, buffering, and all environmentally sensitive features; and (8) set back dimensions from existing property lines.

SITE PLAN (Off-Site Signs):

In addition to the site plan requirements for all signs, the plan for off-site signs must show: (1) off-site signs located on adjacent properties; (2) distance of the proposed sign from the nearest residentially zoned property; (3) angle of opening, if any, between sign panels; and (4) location of off-site signs removed in exchange for this request (provide Certificate of Removal).

CONSTRUCTION DRAWINGS:

The construction plans may be on either legal size or standard plan size. These plans must have scaled drawings of the sign that include the face of the sign, the supporting structure, the foundation, connection details for wall signs, the electrical plan for the illumination of the sign, and the wind analysis evaluation. The plans must be signed, sealed, and dated by a Design Professional registered in the State of Florida.

SECTION H: APPLICANT NOTICE OF SIGN MODIFICATION

Any change to the location, construction, design, or orientation of the sign, after Leon County has approved this permit, may be considered to be a modification of this approval and will require additional review and new approval by Leon County.
