### ADMINISTRATOR'S MESSAGE

October 20, 2011

Fellow Citizens.

The Leon County Board of County Commissioners is proud to present the Adopted Budget in Brief for the fiscal year beginning October 1, 2011 and ending September 30, 2012. This document has been designed to communicate the basic budget information for the adopted FY 2012 annual operating and five-year capital improvement plan.

The adopted budget of \$235,617,730 represents an \$8,512,350 decrease (-3.5%) from last fiscal year. Since FY 2008, the Board has reduced the budget by \$48.9 million or 17%. In addition, the combined ad valorem rate of 8.35 mills did not change from FY 2011 and resulted in lowering property taxes by \$2.9 million countywide.

In spite of the continual decline in taxable values, the Board has made a concerted effort to maintain quality services in the FY 2012 adopted budget. The highest priorities are placed on continuing the level of service for current County programs and maintenance of the County's infrastructure, such as roads, facilities, stormwater improvements and parks.

The Leon LEADS framework was presented to the Board in August 2011. This framework is a strategic transformational approach of aligning the Board's guiding vision and strategic priorities with the optimized resources of the organization while instilling our "People Focused, Performance Driven" culture throughout the organization. Over the next year, during the implementation of LEADS, as an organization we will focus on making the budget process more relevant to our citizens by: detailing how resources provided by the tax payers are utilized for the quality services our citizens expect, aligning the budget with performance measures and desired outcomes, and measuring our performance to meet the expectations of the community in which we live.

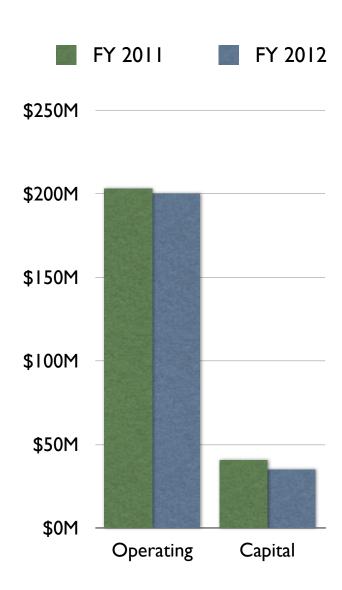
County Administrator

Leon County is approximately 702 square miles. It has a population of approximately 275,487 people, with 94,111 living in the unincorporated area of the County and 181,376 living within the city limits. In November 2002, the County became a charter government, with the passage of a referendum by Leon County voters. A Home Rule Charter gives citizens the power to shape their government to meet their unique and changing needs through a local constitution.

The Board of County Commissioners, whose function is to manage the affairs of the county, is made up of seven members: five elected to serve specific districts and two elected at-large. The County Administrator is appointed by the Board and is responsible for carrying out its directives and policies, as well as the management and supervision of all functions and personnel. The County Attorney, also appointed by the Board, is responsible for the representation of county government, the Board and all departments, divisions, regulatory boards and advisory boards in all legal matters relating to their official responsibilities.

## **FY 2012 BUDGET SUMMARY**

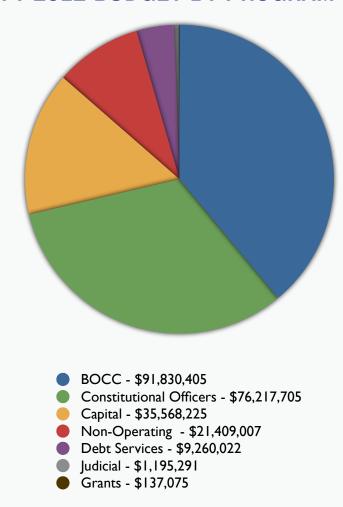
The total FY 2012 budget is \$235,617,730. This represents a reduction of more than \$8.5 million or 3.5% between FY 2011 and FY 2012. The operating budget of \$200,049,505 reflects a decrease of 1.7% from the FY 2011 budget of \$203,453,787, due to budget reductions and Florida Retirement System savings. The FY 2012 capital budget of \$35,568,225 decreased from the FY 2011 budget of \$40,676,293 by \$5.1 million or 12.6%.



## **COUNTY FACT:**

During FY 2011, there were a total of 104 sporting events supported through the Tallahassee Sports Council with 34 different types of sports. The events brought a total of 25,763 room nights with 50,157 actual visitors generating \$24,637,898 in economic impact for the community.

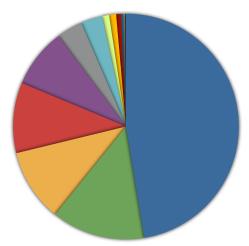

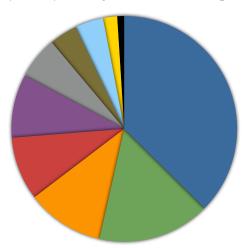

(Median Value Single Family Home in Leon County)

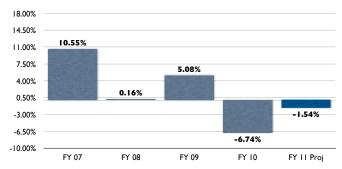

#### **Property Tax Revenues Rate of Change**

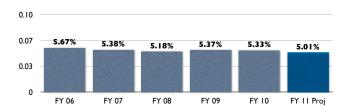


Analysis: In the past ten years, Leon County has become more reliant on property tax revenue, primarily due to the reduction of intergovernmental revenue. The Board maintained the 7.85 rate for FY11. The projected rate of change in FY11 is an increase of 5.20%, due to a moderation of the decline in property values by \$171 million from the previous year. By maintaining the millage rate at 7.85 for FY11, the Board provided \$1.8 million in property tax relief to the citizens of Leon County.

Formula: Current Year minus Prior Year divided by Prior Year.

#### **Debt Service Percentage of Total Operating Expenditures**



Analysis: Debt service is defined as the amount of principal and interest that a local government pays each year on net direct bonded long-term debt, plus the interest on direct short-term debt. Increasing debt service reduces expenditure flexibility by adding to the County's financial obligations. Leon County's debt service has trended downward over the past five years. Leon County maintains level debt service.

Formula: Debt Service divided by Total Operating Expenditures.

#### **General/Fine and Forfeiture Fund Balance**

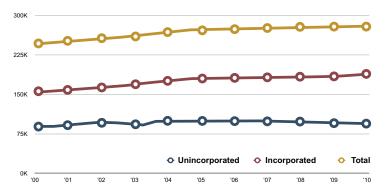


Analysis: Positive fund balances can be thought of as reserves, although the "fund balance" entries on the annual report will not always be synonymous with the funds "available for appropriation." The County's reserve policy requires fund balances to be between a minimum of 15% and a maximum of 30% of operating expenditures. A decline in FY08 fund balance results from \$20 million in appropriations to CIP projects. The FY09 fund balance includes an appropriation of \$3.9 million in local economic stimulus funding. However, this is offset by the return of excess fees from the Constitutional Officers and higher than anticipated interest earnings.

Formula: Prior year fund balance plus actual revenues minus actual expenditures.

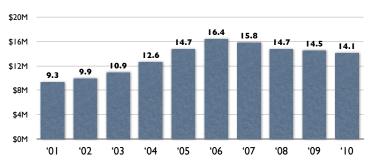

## COMMUNITY ECONOMIC PROFILE



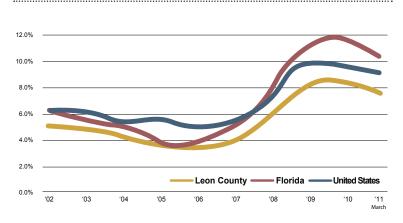
#### **Population**

According to the 2010 United States Census data, the current Leon County population is 275,487; 66% incorporated and 34% unincorporated. Total county population estimates had slowed to less than 1% annual growth since 2006. This trend is anticipated to continue as concluded by the recent Census data. Population estimates include higher education enrollment.



#### **Taxable Values**

Taxable values increased steadily from 1998 to 2006; however, due to property tax reform in 2007, the value of taxable property fell to \$15.8 billion. The decrease in valuation for 2009 is largely due to the recession and a repressed housing market.

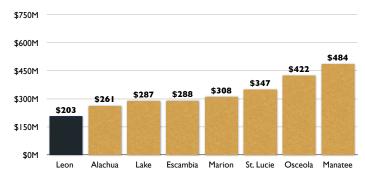


#### **Unemployment Statistics**

Unemployment rates are a traditional indicator of economic health. Leon County's unemployment rate has remained below the state and national averages for the past ten years. In 2009, the state of Florida experienced a 40% increase in unemployment compared to Leon County's 38% increase. The recession further increased Florida's unemployment rate from 10.5% in 2009 to 11.9% in 2010.

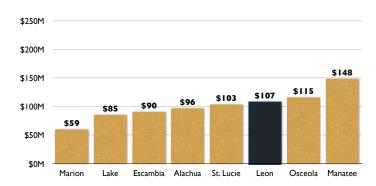
### **HOW WE COMPARE**

#### **Total Net Budget (FY 2011)**



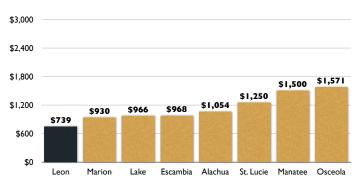
Compared to like-sized counties, Leon County has the lowest net budget.

## **COUNTY FACT:**

During FY 2011, Library Services received \$164,051 in grants and donations, including \$134,266 in State Aid to Libraries, \$12,500 from the National Endowment for the Arts Big Read Program, and \$2,500 for the Big Read grant Match and \$14,785 for a new audiovisual system for the Main Library program rooms from the Friends of the Library.
