### ADDENDUM #2

Dear Vendor:

This letter serves as Addendum #1 for the above referenced project.

Following are questions received with answers following.

1. Page 17, Exhibit A, Console Description : States ECC will have 33 consoles for initial build out and 15 additional for expansion, then page 20, Estimated Costs, states quantity of 26. Need to know how many ECC console positions we should price for the proposal and which area of the current ECC plan is the planned expansion area. Reason for this is there are several different file cabinet designs depending on position / location.

Answer: Pricing should be based on the quantity of 33. Each position should have identical filing capabilities regardless of location. Consoles located closest to the central supervisor cluster will most likely be part of the initial installation. Consoles on the outer band, along the walls, will most likely be future positions, though there is no set methodology as of yet regarding which consoles will be installed initially.

2. Page 2, Required Submittals Work Experience/Completed Projects: Request clarification. It asks for all projects completed and pending in the last 5 years. Should these references be industry specific (Public Safety only). Can we list key projects and furnish more upon request?

Answer: Industry specific projects are preferred, though it is up to the vendor should they have some relevant and similar. Please list no more than 10 projects and what their relation is to the public safety arena.
