DESCRIPTION:

The following RFI's were received on or before 9 March 2010:

- 1. Question:** The Bid issued does not include a location for "Alternates".

Response: See revised Bid Form attached.

- 2. Question:** Plans refer to Alternate 1 in three conflicting locations.

Response: Sheet C3.0 and FS1.0 identified two routes for the sprinkler piping: one as 'base bid' and one as 'alternate 1'. These route identifications conflicted. This has been resolved by Addendum 2. On sheet A7.1 detail view 1, any references to 'Alternate 1' should be stricken, and included in the base bid.
