WATER and WASTEWATER UTILITY RELOCATION
SCOPE OF WORK

Leon County requests the CONTRACTOR to install, adjust, relocate and improve certain potable water distribution and wastewater conveyance facilities within the Project limits of the Buck Lake Road Phases II and III project that are owned and operated by the City of Tallahassee. The work described herein shall hereinafter be referred to as Water Utility Work. The Water Utility Work shall be constructed in conjunction with the Buck Lake Road Phases II and III project. The construction limits of the Water Utility Work are from STA 60+33.98 to STA 122+77.18 (referenced to baseline of construction stationing).

Water Utility Work consists of construction layout; labor; superintendence, main office expense, taxes, quality control, temporary field offices, trench safety measures, erosion and sediment controls, CONTRACTOR's price mark-up, performance bond, insurance; tools, temporary fencing, materials, equipment, mobilization and demobilization, transportation, storage, trenching, dewatering, pipe installation, valves, thrust restraint devices, fire hydrant assemblies, air relief valves, concrete valve collars, bedding, backfill, shoring, bracing, temporary by-pass pumping of sewage; evacuation and disposal of sewage from force mains, flushing water mains, flowable fill, placing water and sewer mains out-of-service, pressure testing, and disinfection of potable water mains, pressure testing of sewer force mains, barricades, maintenance of vehicular traffic, record drawings, security, and all incidentals required for complete and functional installation and adjustment of potable water and wastewater system components.

The Water Utility Work is hereinafter more specifically described in the following documents:

- a) City of Tallahassee Standard Specifications for the Design and Construction of Water and Wastewater Facilities, January 2006, edition, All sections apply to the Contract except section 1 (General Conditions).
- b) Approved construction plans issued by Leon County Public Works Department, as amended.
