ADDENDUM NO. 1

LEON COUNTY COURTHOUSE ROOF COATING

FOR: LEON COUNTY DEPARTMENT OF FACILITIES MANAGEMENT

March 18, 2013

This Addendum forms a part of the contract documents and modifies the drawings and specifications dated January 18, 2013, as noted below.

ITEM NO. 1 - DRAWINGS, SHEET A000: RENOVATION NOTES; PAINTING REPAIRS, NOTE #2, and SPECIFICATIONS SECTION 01010, SUMMARY OF WORK 1.2.D

Change: "Fluorocarbon paint" and "fluoropolymer coating system" to be "premium Industrial Acrylic

Coating System," as specified.

<u>ITEM NO. 2 - DRAWINGS, SHEET A000: LIGHTNING PROTECTION AND RENOVATION NOTES</u>

Clarification: The lightning protection cable and anchor attachments across the field of the roof may remain

and attached to the roof and recoated. The lightning protection cable shall be temporarily elevated (where not fully embedded in the existing coating) to allow roof coating application

and cure time under cables.

Lightning protection cable attachments to the rooftop equipment, roof drains, overflow roof drains, ladders, etc., shall be disconnected for painting the equipment, stands, roof drains, ladders, etc., as specified and then reconnected and bonded per NEC and NFPA 780.

<u>ITEM NO. 3 – DRAWINGS, SHEET A000 RENOVATIONS NOTES and SHEET A100, WORK NOTES</u>

Add/Clarification: Roof walk pads may remain adhered in place; the roof coating should be extended

under the walk pad edges to the extent possible, the pad edges sealed to the coated roof system and the walk pad surface and edges coated with contrasting color roof

coating system from roof coating manufacturer.

<u>ITEM NO. 4 – SPECIFICATION SECTION 071416: FLUID APPLIED WATERPROOF ROOF</u> <u>COATING SYSTEM</u>

Under Quality Assurance 1.4.G and Field Quality Control 3.6.D:

Change Manufacturer's Technical Representative shall be on the site at least twice a month.

Add: The Architect and Manufacturer's Representative shall take a minimum of ten (10) coating samples to test the dry fill thickness of the new coating system at the warranty inspection.

Under Basis of Design Product 2.1.A.1: Change to be "Sealoflex." Add Uniflex and ER Systems to product/manufacturer's list (subject to compliance with requirements).
