The Department of Development Support and Environmental Management has approved this information packet for both Leon County and the City of Tallahassee. A location map of each street has also been included for reference.

Leon County New Street Name Notice

Located in *Fletcher Oaks Subdivision* – In Township and Section 11-24, 1N 1E. All streets are public and paved.

- 1. Fletcher Oaks Dr with an address range of 5600 5699.
- 2. Grand Oaks Rd with an address range of 400 520.
- 3. Manor Oak Pl with an address range of 520 -530.
- 4. Native Oak Dr with an address range of 5640 5700.
- 5. Stately Oaks Pl with an address range of 400 -450.

Not located in a recorded subdivision – *Hidden Pond Ct* - In Township and Section 12-22, 1N 2E – The road is private and unpaved, with an address range of 251 - 295. This access easement is being named in the interest of public safety. Therefore, no street sign fee is required.

Not located in a subdivision – In Township and Section 15-18, 2N 2E - Gaudet Ct – The road is private and unpaved, with an address range of 6050 - 6068.

Leon County Street Renaming Notice

Not located in a subdivision – In Township and Section 32-10, 1S 2E – Bo Nana Trl., has been renamed to "*Billabong Way*". The road is private and unpaved with an address range of 9849 to 9880. A street sign fees are due to the Leon County Public Works – Sign Shop Division. The effective date of change is December 6, 2019.

Leon County and the City of Tallahassee Street Name Clarification Notice

Located in Township and Section 21-06, 1N 1W – The subdivision name of Tower Creek has been re-platted to "*Tower Gates*" Subdivision - All original street names previously approved for this subdivision will not change. Update your tracking systems.

Located under both Leon County and the City of Tallahassee jurisdictions – this street is extending through township and sections 31-04, 05, 10, 11, 12 (1S 1E) and township and sections 32-08, 09, and 10 (1S 2E). Note: the correct spelling for "*Old St Augustine Rd*" not "Old *Saint* Augustine Rd (the use of saint is abbreviated within the correct spelling). All necessary street signs must be corrected through the appropriate governmental agency.

Leon County Rescinded Street Name Notices

Not located in a subdivision – Wiggington Ct – In township and section 21-10 (1N 1W). Based on a recently approved boundary settlement of this location, and the lack of development for this street name dating back to 2005, the name is officially rescinded effective immediately.


City of Tallahassee Rescinded Street Notification






